# AWARDS & CRITERIA



## 01 | AGRI & AQUA BASED INDUSTRY

*Instituted by NSL Group*

**Criteria :** The award is intended for the industry based on Agro & Aqua and is presented in recognition of the excellent performance and contribution made to agriculture as well as Aqua Culture. Selection criteria include productivity, innovation, research and development, CSR, labour welfare and ancillary development, benefits to farmers for improving quality, production and productivity, export and import substitution initiatives

## 02 | EXPORT PERFORMANCE [MICRO & SMALL ENTERPRISE] –MSE

*Instituted by Pokarna Engineered Stone Ltd.*

**Criteria:** Annual turnover up to ₹10 Crore will be considered as Micro Enterprises, and annual turnover up to ₹100 Crore will be considered as Small Enterprises. A division of an enterprise will not be treated as an MSE. Evaluation will also consider market and technological development, overall growth, and net foreign exchange earned.

## 03 | PRODUCT INNOVATION

*Instituted by GM Modular Pvt. Ltd.*

**Criteria:** Innovation and Commercialization of new products.

## 04 | OUTSTANDING WOMEN ENTREPRENEUR

*Instituted by Sri. JS Rao in the memory of Sri JS Krishna Murthy(JSK) Hyderabad Bottling Company Ltd*

**Criteria:** Successfully establish and maintain a business unit, drive product and process innovations and provide employment.

## 05 | START-UP

*Instituted by Laurus Labs Ltd*

**Criteria :** Start up should have game changing idea ( innovation & improvement of products, services & processes) and the potential to generate employment / create wealth.

## 06 | CORPORATE SOCIAL RESPONSIBILITY

*Instituted in the memory of*

*Late Shri BK Goenka by*

*3F Industries, Tadepalligudem, A.P.*

**Criteria:** The Award is intended for excellence in corporate, social and environmental activities and aims to identify the organizations that best illustrate the social and community spirit. The primary criterion is to assess how an organization has integrated CSR into its operations and has implemented and innovated CSR projects or programmes which are impactful and sustainable.

## 07 | EMPLOYEE WELFARE INITIATIVES

*Instituted by CMR Textiles & Jewellers Pvt Ltd.*

**Criteria:** Employee Welfare initiatives would include cumulative efforts and results in family planning, township development, health care, education, etc.

## 08 | ALL ROUND PERFORMANCE

*Instituted by Lalithaa Jewellery Mart Pvt. Ltd.*

**Criteria:** "Industrial Promotion" by an entrepreneur already having an Industrial unit through substantial expansion, introducing new lines of manufacture, diversification, setting up a new industry including through joint ventures with ownership and control, assistance extended to entrepreneurs in putting up new manufacturing units by providing either financial resources or technology know-how or both etc. The main criterion will be contribution to the industrial activity including Research & Development, Social Welfare, Labour Welfare and Ancillary Development.

## 09 | GREEN ENERGY

*Instituted by Greenko Pvt.Ltd*

**Criteria:** This award is to recognise the excellence in renewable sources such as solar, wind and Biofuel plants to accelerate the renewable energy movement in the industry, through wider circulation of best practices. Also, to motivate the industry towards competitiveness, innovation and create knowledge on renewable energy technologies and thereby promoting new alternatives to unconventional energy to reduce the dependence

## 10 | RURAL ENTREPRENEURSHIP

*Instituted by RVR Projects (P) Ltd.*

**Criteria:** Enterprise located in the rural area caters to the rural needs such as employment generation, income generation, rural development, curbing rural – urban migration and improve the standard of living.

## 11 | EXPORT PERFORMANCE – MEDIUM & LARGE ENTERPRISES

*Instituted by Megha Engineering & Infrastructures Limited*

**Criteria:** Annual turnover up to ₹500 Crore will be considered as Medium Enterprises, and annual turnover above ₹500 Crore will be considered as Large Enterprises. Evaluation will also take into account market and technological development, overall growth, and net foreign exchange earned.



# GUIDELINES & CONDITIONS

- Individuals, partnership firms, proprietary concerns, companies, research bodies, industry/trade associations, and organizations operating in Andhra Pradesh are eligible for the FAPCCI Excellence Award.
- Applicants agree to abide by all rules, guidelines, and criteria set by the Awards Committee.
- The Committee reserves the right to revise or expand criteria for the Awards at any time.
- A recipient is not eligible for the same award for two years from the date of receiving it. However, if a company has multiple autonomous units engaged in different products/services, another unit may apply the following year.
- The Awards Committee may advise entries to move to the more appropriate category.
- Members of the Managing Committee, Past Presidents, and members of the Awards Committee of FAPCCI are not eligible to apply for the Awards. Additionally, sponsors of respective award category are not eligible to apply for the award sponsored.
- For organizations with nationwide operations, only the performance of the unit located in Andhra Pradesh will be evaluated.
- The Awards Committee/Jury will evaluate all applications. The Committee may co-opt domain experts if needed. The jury's decision is final and binding.
- Entries must be submitted only through the prescribed application form from the FAPCCI office or website.

## ENROLLMENT PROCESS

The application consists of Two Parts:

- **Part I:** Information for the financial year ending 31.03.2025 and the two preceding years.
- **Part II:** Information specific to the Award Category.
  - Applicants must submit printed/photocopies of the filled-in application along with a soft copy.
  - Entries may also be submitted via email to [info@fapcci.in](mailto:info@fapcci.in).
  - Participants should download the application form from the FAPCCI website, fill it with all required supporting documents, and submit before the due date.
  - Applications will be accepted only upon receipt of the entry fee (non-refundable)
